Transcripts must be in a sealed envelope from your high school. Photocopies, faxes and online print-outs are not permitted. Transcripts will not be returned. Scholarship awards will be paid to winner's school after August 1, 2017. If scholarship recipients are not DCU members, they must open a DCU Share Savings Account with minimum \$25 deposit by July 31, 2017.
